

V Arcade machine Promotion – Terms and Conditions of Entry

1. Information on how to enter and prizes form part of these conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions.
2. The promotion is only open to New Zealand residents who are aged 18 years or over and are registered members of the AA Smartfuel programme. Employees of the Promoter and BP Oil NZ and their immediate families, as well as the owners, managers, and staff of each Participating Store (“**Agents**”) and their immediate families, are ineligible to enter. Employees of AA Smartfuel Limited or The New Zealand Automobile Association Incorporated (NZAA), and their immediate families, are also ineligible to enter. The Promoter reserves the right to request proof of an entrant’s eligibility in the event that there is a doubt over his/her eligibility for the promotion..
3. The V Arcade Promotion commences at 12.01 am on 25th November 2019 and finishes 11.59pm on 19th January 2020 (“**Promotion Period**”). Entries received prior to 25th November 2019 will not be entered into the prize draw.
4. To enter the promotion, purchase any two V products (“**Qualifying Products**”) in one transaction from a participating BP Connect or BP 2go Service Station (“**Participating Stores**”) during the Promotion Period, and swipe an AA Membership or registered AA Smartfuel card.
5. You may enter the promotion as many times as you like provided that each entry is through a separate purchase of two of the Qualifying Products in one transaction. For the avoidance of doubt, V multi-packs count as one product.
6. There are three (3) prizes of a V Arcade with an RRP of \$3900 NZD to be won (“**Prize**”). The Prizes are not transferable, changeable or redeemable for cash.
7. In the event that the Prize or any part of the Prize becomes unavailable for any reason beyond the Promoter’s control, the Promoter may in its sole discretion decide to provide an alternative prize.
8. The winners will be drawn at 12.00pm on Wednesday 22nd January 2020 at the offices of Radium, which has its registered office at Level 3, 10 Hutt Road, Lower Hutt. The Prizes will be awarded to the first three (3) valid entries randomly drawn from all eligible entries
9. Each winner will be the person listed as the primary cardholder on the winning AA Membership or AA Smartfuel account (regardless of who made the Qualifying Purchase). Neither the Promoter, BP Oil New Zealand Limited, nor Radium will be responsible in any way for any disputes arising as a result of entries being submitted by persons other than the primary card holder.
10. In the event that a winner is under 18 years old, the prize may be awarded to that Winner’s parent or guardian, in the sole discretion of the Promoter.
11. The winners will be contacted by phone to the phone number listed on the nominated AA Membership or AA Smartfuel accounts associated with the winning entries. Entrants should ensure their contact details on their AA Membership or AA Smartfuel accounts are current and correct.
12. In case an invalid entry or ineligible entrant is drawn as a winner, the prize is forfeited, or if the Promoter is unable to contact the winner within seven days of the prize draw, having made reasonable attempts to do so, the Promoter may deem that winner’s entry invalid and select a new winner on the same terms as the original prize draw.

13. If the winner cannot accept or take part in the Prize for any reason, their Prize will be void and no compensation will be payable.
14. The Promoter's decision (or the decision of its employees or agents) is final on all matters and no correspondence will be entered into.
15. The Promoter reserves the right to amend, suspend or cancel any aspect of this promotion (including any Prize or term) at any time in its sole discretion.
16. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
17. The prize will be delivered to the particular address nominated by the prize winner. Delivery of the Prize is valid to any residential address in New Zealand.
18. The Promoter reserves the right to disallow entries in its absolute discretion and without giving reasons.

The Promoter reserves the right to verify the validity of the winner's entry and disqualify any entry or refuse to award a prize where false or misleading details have been given by an entrant or an entrant has behaved in a fraudulent, dishonest or disruptive manner, or otherwise than in accordance with these terms and conditions or the spirit of the promotion.
20. Acceptance of a Prize is deemed consent for the Promoter to use the winner's details for promotional and media purposes without any claim to compensation from the winners, and the ensuing copyright will rest with the Promoter.

The time entries are deemed to be made will be the time the entry is received, not the time the entry is submitted by an entrant.

The Promoter and its agents collect and hold personal information provided with each entry to be used for the purposes of the promotion and in particular to notify the winners and to verify the identities of the winners. Failure to provide requested personal information may disqualify a person from being able to receive a prize.
